



WEST COUNTY WASTEWATER'S COMMUNITY CLEANUP EVENT VOLUNTEER WAIVER AND RELEASE OF LIABILITY

I am voluntarily participating in West County Wastewater's ("WCW") Community Cleanup event being held at Wild Canyon Regional Park Alvarado Area on April 13, 2025 ("Event"). I hereby represent and agree as follows:

1. My participation in the Event is purely voluntary without any expectation of financial remuneration.
2. I understand that Event volunteers will engage in moderate physical activities including walking on unpaved trails and other uneven terrain including creek beds. I further understand that as part of the Event, I may encounter sharps, needles, and other potentially hazardous materials that have been left as trash within the Event area.
3. I am aware that my participation in the Event may involve risk of injury, adverse medical condition, loss or damage to me or my property or other consequences, including, without limitation, contraction of COVID-19 and death. These risks of injury, loss or damage might result from my own actions or negligence, or the actions or negligence of others, or the conditions of the premises or of any equipment used. I acknowledge that there may be other risks to me that are not known or not reasonably foreseeable.
4. During the Event, I agree to follow all directions and guidelines given by WCW, the East Bay Regional Park District, and other designated Event officials.
5. I agree to assume all of the above risks. I also release, waive, discharge, and promise not to sue WCW and its directors, members, employees, officers, agents, affiliated companies, and insurers from any and all liability for injury, adverse medical condition, loss or damage to my person or property, or any other consequence in connection with my participation in the Event. I waive the protections of California Civil Code Section 1542, which provides that a general release does not extend to certain claims not known to me at the time I signed this waiver and release of liability. I understand that WCW would not permit me to volunteer without my agreeing to this waiver and release of liability.



6. I agree to indemnify, defend and hold harmless WCW and its directors, members, employees, officers, agents, affiliated companies, and insurers from any and all damages, losses, liabilities, fees and costs incurred in connection with any third party claims or threats of claims, including any claim from any of my invitees, asserted arising from or relating to my participation in or conduct associated with the Event.
7. I intend this release and hold harmless agreement to forever bind myself as well as my estate, personal representatives, guardians, conservators, heirs, executors, administrators, next of kin, and assigns.
8. I hereby grant WCW the absolute and irrevocable, transferrable (in whole or in part), royalty free right to use, modify, publish, publicly display and copy any resemblance, recording, or image, including, without limitation, audio recordings, video recordings, and photographs, in whole or in part, that WCW, its directors, members, employees, officers, agents, and affiliated companies, take of me during the Event ("Material") with or without name identification or my approval for illustration, trade, advertising, marketing and promotion of WCW, or for any other purpose related to WCW anywhere in the world and in any medium ("License"). I hereby release and discharge WCW, its directors, members, employees, officers, agents, and affiliated companies, and their respective successors, and assigns (including any agency, client, designer, periodical or other publication) from any and all claims and demands arising out of or in connection with the use of the Material consistent with the License, including, but not limited to, any claims for copyright infringement, defamation, invasion of privacy or right of publicity.
